



SCHOOL CLIMATE IN

PUERTO RICO

Findings from the GLSEN 2017 National School Climate Survey demonstrate that schools in Puerto Rico were not safe for most lesbian, gay, bisexual, transgender, and queer (LGBTQ) secondary school students. In addition, many LGBTQ students in Puerto Rico did not have access to important school resources, such as Gay-Straight Alliances/Gender and Sexuality Alliances (GSAs) or similar student clubs, and were not protected by supportive and inclusive school policies.


FACT: The vast majority of LGBTQ students in Puerto Rico regularly (sometimes, often, or frequently) heard anti-LGBTQ remarks (Fig. 1). Many also regularly heard school staff make homophobic remarks (29%) and negative remarks about someone's gender expression (48%).


Figure 2. Anti-LGBTQ Harassment & Assault in Puerto Rican Schools (percentage of LGBTQ students harassed or assaulted in the past year based on...)

FACT: Most LGBTQ students in Puerto Rico experienced anti-LGBTQ victimization at school (Fig. 2). They also experienced victimization at school based on religion (31%), disability (22%), and race/ethnicity (24%). Most never reported the incident to school staff (56%). Only 39% of students who reported incidents said it resulted in effective staff intervention.


Figure 3. Anti-LGBTQ Discrimination in Puerto Rican Schools (percentage of LGBTQ students that were prevented from...)

FACT: Many LGBTQ students in Puerto Rico reported discriminatory policies or practices at their school (Fig. 3). Nearly 3 in 4 (71%) experienced at least one form of anti-LGBTQ discrimination at school during the past year.

- Over 2 in 5 LGBTQ students (41%) in Puerto Rico were unable to wear clothing considered inappropriate for their gender.
- In Puerto Rico, approximately 1 in 3 LGBTQ students (29%) and almost 3 in 4 transgender students (73%) were unable to use the school restroom aligned with their gender. Additionally, nearly 1 in 5 of LGBTQ students (18%) and almost 3 in 4 transgender students (73%) were prevented from using their chosen name or pronouns in school.
- LGBTQ students in Puerto Rico experienced other forms of school discrimination (not in Fig. 3): being unable to wear LGBTQ-supportive apparel (18%), being unable to bring a same-gender date to a school dance (16%), being unable to form a GSA (16%), being disciplined at school for identifying as LGBTQ (9%), and being prevented or discouraged from playing school sports due to an LGBTQ identity (7%).

FACT: Many LGBTQ students in Puerto Rico did not have access to in-school resources and supports (Fig. 4).

- Fewer than 1 in 10 (7%) attended a school with a comprehensive anti-bullying/harassment policy that included specific protections based on sexual orientation and gender identity/expression. Fewer than 1 in 10 (7%) had a policy or official guidelines to support transgender or gender nonconforming (trans/ GNC) students.
- Only 1 in 5 (19%) reported that their school administration was somewhat or very supportive of LGBTQ students.
- The vast majority (93%) could identify at least one school staff member supportive of LGBTQ students (not in Fig. 4), but only 43% could identify 6 or more supportive school staff.
- Only 1% had access to a GSA or similar student club which provides a safe and affirming space and promotes a more welcoming school climate for LGBTQ students.

• Only 1 in 5 (20%) were taught positive representations of LGBTQ people, history, or events ("inclusive curriculum"). Only 1 in 10 (11%) reported receiving LGBTQ-inclusive sex education at school (not in Fig. 4).

RECOMMENDATIONS

School-based supports such as supportive and inclusive school policies, school personnel who are supportive of LGBTQ students, GSAs, and LGBTQ-inclusive curricular resources can positively affect school climate for LGBTQ students. Findings from the 2017 National School Climate Survey demonstrate that students attending schools with these resources and supports report more positive school experiences, including lower victimization and absenteeism and higher academic achievement.

Given the high percentages of LGBTQ students in Puerto Rico who experience harassment at school and the limited access to key resources and supports that can have a positive effect on their school experiences, it is critical that school leaders, education policymakers, and other individuals in Puerto Rico who are obligated to provide safe learning environments for all students take the following steps:

- Implement supportive and inclusive school policies, such as comprehensive anti-bullying/harassment and supportive transgender and gender nonconforming student policies;
- Support GSAs;
- Provide professional development for school staff on LGBTQ student issues; and
- Increase student access to LGBTQ-inclusive curricular resources.

These actions can move us toward a future in which all students in Puerto Rico will have the opportunity to learn and succeed in school, regardless of sexual orientation, gender identity, or gender expression.

ABOUT THE RESEARCH In 2017, GLSEN conducted the tenth National School Climate Survey, a biennial survey of the experiences of LGBTQ youth in U.S. secondary schools. The national sample consisted of 23,001 LGBTQ students from all 50 states, the District of Columbia, and all 5 major U.S. territories. A total of 163 respondents were attending schools in Puerto Rico. The Puerto Rico sample was majority Hispanic/Latinx (94%), 4% White, < 1% Black/African American, < 1% Multiracial, 0% Asian/South Asian/Pacific Islander, 0% Native American, and 0% Arab/Middle Eastern. The gender composition was 77% cisgender, 8% transgender, 8% genderqueer, and 7% another gender (e.g. questioning, genderfluid). Most (69%) attended public schools. The school community makeup was 21% rural/small town, 19% suburban, and 60% urban. The results reported for Puerto Rico had a margin of error of +/- 8%.
