


## SCHOOL CLIMATE IN IOWA

Findings from the GLSEN 2017 National School Climate Survey demonstrate that Iowa schools were not safe for most lesbian, gay, bisexual, transgender, and queer (LGBTQ) secondary school students. In addition, many LGBTQ students in Iowa did not have access to important school resources, such as an LGBTQ-inclusive curriculum, and were not protected by supportive and inclusive school policies.


**FACT: The vast majority of LGBTQ students in Iowa regularly (sometimes, often, or frequently) heard anti-LGBTQ remarks (Fig. 1).** A portion also regularly heard school staff make homophobic remarks (19%) and negative remarks about someone's gender expression (40%).


**Figure 2. Anti-LGBTQ Harassment & Assault in Iowa Schools**

**FACT: Most LGBTQ students in Iowa experienced anti-LGBTQ victimization at school (Fig. 2).** They also experienced victimization at school based on religion (29%), disability (25%), and race/ethnicity (21%). Most never reported the incident to school staff (51%). Only 22% of students who reported incidents said it resulted in effective staff intervention.

(percentage of LGBTQ students hearing remarks regularly)


**Figure 3. Anti-LGBTQ Discrimination in Iowa Schools**

**FACT: Many LGBTQ students in Iowa reported discriminatory policies or practices at their school (Fig. 3).** Nearly 3 in 5 (59%) experienced at least one form of anti-LGBTQ discrimination at school during the past year.

- One-third of LGBTQ students (33%) in Iowa were disciplined for public displays of affection (PDA) that did not result in similar action for non-LGBTQ students.
- In Iowa, over 1 in 4 LGBTQ students (27%) and half of transgender students (49%) were unable to use the school restroom aligned with their gender. Additionally, nearly 1 in 4 LGBTQ students (23%) and more than 2 in 5 transgender students (44%) were prevented from using their chosen name or pronouns in school.
- LGBTQ students in Iowa experienced other forms of school discrimination (not in Fig. 3): being unable to form a GSA (14%), being unable to wear LGBTQ-supportive apparel (13%), being unable to bring a same-gender date to a school dance (12%), being prevented or discouraged from playing school sports due to an LGBTQ identity (11%), and being disciplined at school for identifying as LGBTQ (3%).

**FACT: Many LGBTQ students in Iowa did not have access to in-school resources and supports (Fig. 4).**

- Fewer than 1 in 5 (18%) attended a school with a comprehensive anti-bullying/harassment policy that included specific protections based on sexual orientation and gender identity/expression. Fewer than 1 in 10 (8%) had a policy or official guidelines to support transgender or gender nonconforming (trans/GNC) students.
- Fewer than 2 in 5 (38%) reported that their school administration was somewhat or very supportive of LGBTQ students.
- The vast majority (97%) could identify at least one school staff member supportive of LGBTQ students (not in Fig. 4), but fewer (56%) could identify 6 or more supportive school staff.
- Nearly half (48%) had access to a GSA or similar student club which provides a safe and affirming space and promotes a more welcoming school climate for LGBTQ students.
- Only approximately 1 in 10 (14%) were taught positive representations of LGBTQ people, history, or events (“inclusive curriculum”). Only 3% reported receiving LGBTQ-inclusive sex education at school (not in Fig. 4).

**RECOMMENDATIONS**

School-based supports such as supportive and inclusive school policies, school personnel who are supportive of LGBTQ students, GSAs, and LGBTQ-inclusive curricular resources can positively affect school climate for LGBTQ students. Findings from the 2017 National School Climate Survey demonstrate that students attending schools with these resources and supports report more positive school experiences, including lower victimization and absenteeism and higher academic achievement.

Given the high percentages of LGBTQ students in Iowa who experience harassment at school and the limited access to key resources and supports that can have a positive effect on their school experiences, it is critical that Iowa school leaders, education policymakers, and other individuals who are obligated to provide safe learning environments for all students take the following steps:

- Implement supportive and inclusive school policies, such as comprehensive anti-bullying/harassment and supportive transgender and gender nonconforming student policies;
- Support GSAs;
- Provide professional development for school staff on LGBTQ student issues; and
- Increase student access to LGBTQ-inclusive curricular resources.

These actions can move us toward a future in which all students in Iowa will have the opportunity to learn and succeed in school, regardless of sexual orientation, gender identity, or gender expression.

**ABOUT THE RESEARCH** In 2017, GLSEN conducted the tenth National School Climate Survey, a biennial survey of the experiences of LGBTQ youth in U.S. secondary schools. The national sample consisted of 23,001 LGBTQ students from all 50 states, the District of Columbia, and all 5 major U.S. territories. A total of 385 respondents were attending schools in Iowa. The Iowa sample was majority White (84%), 8% Hispanic/Latinx, 5% Multiracial, 2% Asian/South Asian/Pacific Islander, < 1% Black/African American, < 1% Native American, and 0% Arab/Middle Eastern. The gender composition was 57% cisgender, 20% transgender, 9% genderqueer, and 15% another gender (e.g. questioning, genderfluid). Most (96%) attended public schools. The school community makeup was 53% rural/small town, 21% suburban, and 26% urban. The results reported for Iowa had a margin of error of +/- 5%.
